# **Come to the Africa Centre on March 19!**

**FACT 1:** South Africa has the worst system of institutionalised racism in the world — apartheid. Under it a white minority holds political and economic power and uses it to exploit the black majority and deprive them of basic human rights

**FACT 2:** South Africa is illegally occupying a neighbouring country — Namibia. The United Nations has revoked the mandate over Namibia which South Africa was given after the First World War: but South Africa has moved at least 50,000 troops and military personnel into the country to fight against Namibia's liberation movement SWAPO.

**FACT 3:** South Africa has been attacking its other neighbours — Lesotho, Angola, Mozambique and Zimbabwe — killing their people, strangling their economies and trying to overthrow their Governments.

Most Londoners would say they are against apartheid and that they think South Africa should let its neighbours live in peace.

But then they say — what can we do? South Africa is 6000 miles away — what has it got to do with us?

At the Africa Centre on March 19 we are going to discuss what we can do. In particular how we can

- end all the ways in which Britain supports apartheid — through arms sales, trade, investment, emigration, nuclear collaboration, sports and cultural exchanges
- act against South Africa's illegal occupation of Namibia — by campaigning for the British Government to support the implementation of Resolution 435 which sets out a procedure leading to Namibian independence and by giving direct support to SWAPO, Namibia's liberation movement
- support Southern African detainees and political prisoners, especially the ANC Six who are under sentence of death and join in the international campaign for the freedom of ANC leader Nelson Mandela
- publicise South Africa's attacks on its neighbours and help build up a movement in Britain of support for the front-line states
